- 5. Discussion and appropriate action on adoption of the Bexar County ESD No. 8 Fiscal Year 2020 Budget. Commissioner Voss made a motion to accept the Bexar County ESD No. 8 Fiscal Year 2020 Budget. Commissioner Yates seconded. The motion carried by a vote 3-0
- 6. Action to approve by voice vote Order 091019-6 of the Bexar County Emergency Services District No. 8 levying the ad valorem taxes for the 2019 tax year at a rate of \$ 0.09923 per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 8 to provide revenue for maintenance and operation needs for the 2019 fiscal year; and at a rate of \$ 0.00 (zero) per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 8 to provide revenue for debt service needs for the 2019 fiscal year.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.5 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$ 100,000 HOME BY APPROXIMATELY \$3.41.

Action to approve by voice vote Order 091019-6 of the Bexar County Emergency Services District No. 8 levying the ad valorem taxes for the 2019 tax year at a rate of \$ 0.09923 per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 8 to provide revenue for maintenance and operation

needs for the 2020 fiscal year; and at a rate of \$ 0.00 (zero) per \$ 100 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 8 to provide revenue for debt service needs for the 2020 fiscal year.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.5 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$ 100,000 HOME BY APPROXIMATELY \$3.41.

Commissioner Yates made a motion that the property tax rate be increased by the adoption of a tax rate of \$ 0.09923 per \$100 assessed valuation which is effectively a 3.5 percent increase in the tax rate. Commissioner Voss seconded. The motion carried 3-0

- 8. Update on the Fire Station No. 2 Project.

 Commissioner Yates provided update on Station No. 2 project. Items of note included the signing of agreement for materials testing, and the signing of a contract with Seidel Construction to begin construction.
- **9.** Update on a possible location for Fire Station No. 3. Chief Reddout provided update on discussions he had with real estate representative. Discussions are ongoing and property search for Fire Station No. 3 continues.
- 10. Chief's Report. Chief Reddout provided the Board with a review of the number of calls for service. Items of note this month included assistance provided to Leon Springs and ESD 7 with structure fires. Discussion and updated on staff medical evaluations and status on ladder truck research. Additionally there is one open position on A shift.
- 11. Review of the financial reports for the District. Financial reports reviewed for the period.
- 12. Review of the meeting planner and requests from the Board for any agenda items to consider at the next meeting scheduled for October 8, 2019. *Item up for discussion during next meeting will be to discuss engagement with CPA for 2019 fiscal year audit*
