

## Bexar County Emergency Services District No. 8 March 12, 2024 at 6:30 P.M. Meeting Minutes



The Bexar County Emergency Services District No. 8 will conduct a meeting at the Emergency Services District No. 8 Fire Station located at 20825 Babcock Rd, San Antonio, Texas 78255 on March 12, 2024 beginning at 6:30 P.M.

## The following will be discussed with possible action as necessary:

- 1. Call the Bexar County Emergency Services District No. 8 Meeting to Order and establish a quorum. Commissioner Hune called the Bexar County Emergency Services District No. 8 meeting to order at 6:35 P.M. and established a quorum.
- 2. Pledge of Allegiance. Pledge of Allegiance was recited.
- 3. Citizens to be heard. (Individuals have 3 minutes) No Citizens signed up to speak.
- 4. Approval of the minutes from the meetings held on February 13, 2024. Commissioner Voss made a motion to accept the minutes as written. Commissioner Thornton seconded. The motion carried by a vote 3-0
- 5. Discussion and possible action related to the Station 3 project. Mark Price with AGCM provided an update on timing and key dates upcoming for Station 3 project. Pending items include geotechnical report, street address, and water/gas service.
- 6. Discussion and possible action related to the Bexar County Emergency Services District No. 8 investment policy. Commissioner Thornton made a motion to have the Board instruct administrator to manage banking accounts to have a general fund balance of \$750,000, payroll account balance of \$80,000, and remaining funds invested in Texpool or TexClass account. Commissioner Voss seconded. The motion carried by a vote of 3-0
- 7. Discussion and possible action related to the disability coverage for Bexar County Emergency Services District No. 8 to comply with HB 471. Commissioner Thornton made a motion to pursue option #1 as presented to comply with HB 471. Commissioner Voss seconded. The motion carried 3-0
- 8. Chief's report. Chief Reddout provided a review of the number of calls for service, and a review of overall response times. This month's noteworthy activity included 2 possible house fires\*\*\*unresponsive critical patient, ESD 8 had two paramedics on scene to stabilize patient; simultaneously another crew went to a second medical call, no disruption in services to our citizens. Public Relations included assisting HOA at Rancho Dianna with gate issues. Two personnel enrolled in paramedic programs.
- 9. Administrators Report. Financial reports reviewed for the period.

- 10. Call for items to be considered at the meetings scheduled for April 9, 2024. *No extraordinary items called out for next meeting.*
- 11. Adjourn. With no further business before the Board the meeting was adjourned at 7:45 p.m
