The Bexar County Emergency Services District No. 8 will conduct a meeting at the Emergency Services District No. 8 Fire Station located at 20825 Babcock Rd, San Antonio, Texas 78255 on October 24, 2023 beginning at 6:30 P.M.

The following will be discussed with possible action as necessary:

1. Call the Bexar County Emergency Services District No. 8 Meeting to Order and establish a quorum. *Commissioner Hune called the Bexar County Emergency Services District No. 8 meeting to order at 6:30 P.M. and established a quorum.*
2. Pledge of Allegiance. *Pledge of Allegiance was recited.*
3. Citizens to be heard. (Individuals have 3 minutes) *There were no citizens signed up to speak.*
4. Approval of the minutes from the meetings held on September 12, 2023. *Commissioner Thornton made a motion to accept the minutes as written. Commissioner Voss seconded. The motion carried by a vote 4-0*
5. Discussion and possible action related to the Station 3 project. *Baetty Palmer design team and AGCM project management team walked through the update design and costs for Station 3. A follow-up meeting was scheduled for November 28<sup>th</sup> at 6:30. No action was taken.*
6. Discussion and possible action regarding investment options for Bexar County Emergency Services District No. 8. *Discussion around maintaining sufficient amount of funds in general operating account while taking advantage of favorable interest rate environment. Commissioner Thornton made a motion to move \$750,000 from the general checking account into the PIAF compliant investment fund. Commissioner Voss seconded, the motion carried by a vote 4-0*
7. Chief's report. *Chief Reddout provided the Board a review of the number of calls for service, and a review of overall response times. Items of note this month include Three possible house fires in Leon Springs\*\*\*Cardiac arrest in district\*\*\*Possible stroke / cardiac issue at Grey Moss Inn\*\*\*Grass fire caused by CPS powerlines being worked on by contractor\*\*\*Contractors truck caught fire in Canyons, only truck damaged, no extension to trailer or excavator.*
8. Administrators Report. *Review of financial reports*
9. Call for items to be considered at the next meeting scheduled for November 14, 2023. *No special agenda items called out for November meeting.*

10. Adjourn. *With no further business before the Board the meeting was adjourned at 8:05 p.m.*
